ORDINANCE NO 13 OF THE RECTOR OF THE UNIVERSITY OF WARSAW

of 25 January 2017

on physical education classes

Pursuant to § 2 s. 1 of resolution no 36 of the Senate of the University of Warsaw of 21 December 2016 on guidelines for drawing up study curricula (UW Monitor, 2016, item 427), it is hereby ordered as follows:

§ 1

- 1. The study curriculum of the first-cycle studies should include 90 hours of obligatory physical education classes.
- 2. The study curriculum of the long second-cycle studies should include 90 hours of obligatory physical education classes.
- 3. Students of the full-time first-cycle studies or full-time long second-cycle studies shall be entitled, depending on the availability, to participate in additional free physical education classes in the amount of 60 hours. This entitlement shall be acquired after completing obligatory physical education classes.
- 4. Students of the part-time first-cycle studies, part-time long second-cycle studies and full-time or part-time second-cycle studies shall be entitled, depending on the availability, to participate in non-obligatory obligatory free physical education classes in the amount of 30 hours.
 - 5. No ECTS credits shall be allocated to classes referred to in ss. 1-4.

§ 2

Physical education classes, referred to in § 1 ss. 1 and 2, shall be carried out:

- 1) in case of the first-cycle studies during the first five semesters of the studies;
- 2) in case of long first-cycle studies during the first six semesters of the studies.

A student, who registered for obligatory, non-obligatory or additional free physical education classes and failed to complete the assessment, shall lose the right to participate in these classes free of charge.

§ 4

A student may participate in physical education classes in any number of hours, depending on the availability.

§ 5

- 1. The Physical Education and Sports Centre shall be entrusted with:
- 1) laying down the principles for registration for free and paid physical education classes;
- 2) conducting registration for physical education classes both free and paid;
- 3) laying down the principles for participation in physical education classes;
- 4) completing the assessment with respect to physical education classes;
- 5) setting the amount of the fees for paid physical education classes;
- 6) collecting the fees for paid physical education classes.
- 2. The principles referred to in s. 1 points 1, 3 and 4 and the amount of the fees referred to in s. 1 point 5 shall be approved by the Rector.

§ 6

- 1. Study curricula approved by the Senate of the University of Warsaw before 1 October 2016 shall remain in force.
- 2. Ordinance no 24 of the Rector of the University of Warsaw of 14 September 2006 on the amount of additional physical education classes (UW Monitor 2006 No 8, item 132) shall be hereby cancelled.
- 3. The ordinance shall come into force on the day of its signing, except for § 1 ss. 1, 2 and 5, and § 2 that shall apply to students beginning their studies in the 2017/2018 academic year and later.
